**RELEASE OF TRADEMARK COLLATERAL ASSIGNMENT AND
SECURITY AGREEMENT**

This Release of Trademark Collateral Assignment and Security Agreement (this "Release") is given as of November 4, 2010, by Bank of America, N.A. (as successor to Fleet Capital Corporation), a National Banking Association, with an address of 901 Main Street, 11th Floor, TX1-492-11-23, Dallas, Texas 75202 (the "Agent") for the benefit of Ivy Steel & Wire, Inc. (successor to MMI Management Services LP), a Delaware corporation, with an address of 400 N. Sam Houston Pkwy E., Suite 1200, Houston, Texas 77060 (the "Debtor");

WHEREAS, Debtor has fully discharged and satisfied the obligations secured by the Trademark Collateral Assignment and Security Agreement dated August 12, 2002 (the "Security Agreement"). The Security Agreement was recorded in the United States Patent and Trademark Office at Reel 2632/Frame 0241 against the trademarks attached hereto as Exhibit A (the "Trademark Collateral"); and


WHEREAS, Debtor has requested that the Agent release, and the Agent is willing to release, subject to the terms hereof, its security interest, and any other right, title and interest it may have in and to the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Agent does hereby terminate and release any and all security interests and all other right, title or interest that it may have in, to or under, the Trademark Collateral and thereby discharge the recordation of the Security Agreement against the Trademark Collateral.
2. Agent agrees to take such further action as may be reasonably requested by Debtor, from time to time, at Debtor's expense, to effectuate and carry out the provision and intent of this Release.
3. Agent represents and warrants to Debtor that it has not conveyed, transferred, granted a security interest in, hypothecated or otherwise pledged or disposed of any of the rights, title or interest granted to the Trademark Collateral under the Security Agreement to any party other than Debtor.
