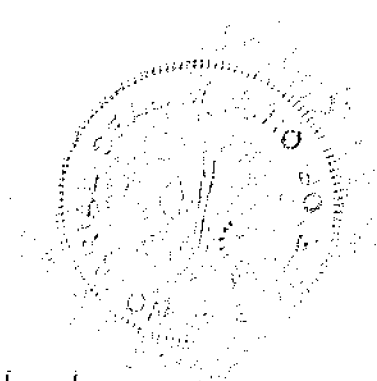
**RELEASE OF TRADEMARK SECURITY AGREEMENT**
