Articles of Amendment to the
Articles of Incorporation
of
SIMULA, INC.

Pursuant to Section 10-1006 of the Arizona Revised Statutes, the undersigned Corporation adopts the following amendments to its Articles of incorporation:

1. The name of the corporation (hereinafter called the "Corporation") is Simula, Inc.

2. The following amendments were adopted the 31st day of July, 2007.

3. Article FIRST of the Articles of Incorporation of the Corporation is hereby amended by the deletion of the current text thereof in its entirety and the substitution in its place of the following text:

"FIRST: The name of the corporation is BAE Systems Simula Inc."

4. Article FOURTH of the Articles of Incorporation of the Corporation is hereby amended by the deletion of the first sentence thereof in its entirety and the substitution in its place of the following text:

"FOURTH: The name and street address in Arizona of the statutory agent of the corporation is C T Corporation System, 2394 East Camelback Road, Phoenix, Arizona 85016."

5. The foregoing amendments to the Articles of Incorporation of the Corporation have been duly approved pursuant to Section 10-1003 of the Arizona Revised Statutes and by the governing documents of the entity.

6. The shares outstanding and entitled to vote on the amendment were 100 shares of common shares entitled to 100 votes, and no other shares were entitled to vote as a class or series.

7. The number of votes for the approval of the amendment was 100. The number of votes against the approval of the amendment was 0. The number of votes cast for approval of the amendment was sufficient for approval by the voting group.

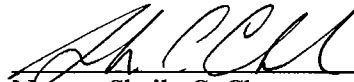
8. The amendment does not provide for an exchange, reclassification or cancellation of issued shares.

This Certificate of Amendment to the Articles of Incorporation of the Corporation shall become effective upon its filing by the Arizona Corporation Commission of the State of Arizona.
