**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE dated as of November 17, 2010, by HSBC BANK, USA, NATIONAL ASSOCIATION as Security Agent (the "Agent") for certain banks and other financial institutions (the "Lenders"), to Columbian Chemicals Company, a Delaware corporation having an address at 1800 West Oak Commons Court, Marietta, Georgia 30062-2253 (the "Grantor").

WITNESSETH:

WHEREAS, pursuant to that certain Security Agreement entered into by the Grantor and J P. Morgan Chase Bank Seoul Branch on March 16, 2006 in favor of the Agent (as amended, the "Security Agreement"), a security interest (the "Security Interest") was granted by the Grantor to the Agent in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, pursuant to that First Amendment to the Credit Facilities dated March 16, 2006, HSBC BANK, USA, NATIONAL ASSOCIATION became Security Agent for the banks and other financial institutions under the Security Agreement;

WHEREAS, pursuant to that certain Supplement to Security Agreement (Trademarks) dated as of March 16, 2006 (the "Trademark Security Agreement"), Grantor, by reference to the Security Agreement, reaffirmed its intent to grant a Security Interest to the Agent specifically in certain Trademark Collateral;

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on March 22, 2006, at Reel 3274 and Frame 0423; and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

1. Definitions. The term "Trademark Collateral," as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the Trademarks (including, without limitation, those items listed on Schedule A hereto). The term "Trademarks" shall have the meaning provided by reference in the Trademark Security Agreement.

2. Release of Security Interest. The Agent hereby terminates, releases and discharges its Security Interest in the Trademark Collateral, and any right, title or interest of the Agent in such Trademark Collateral shall hereby cease and become void.

3. Further Assurances. The Agent hereby agrees, at the expense of the Grantor, to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably requested by the Grantor to effect the release of the Security Interest contemplated hereby.


