This assignment is entered into this 12 day of November, 2010 to be effective December 9, 2003.

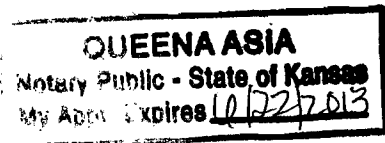
