## INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Intellectual Property Security Agreement is entered into as of November 19, 2010 by and between Revenue Loan, LLC, a Delaware limited liability company ("Lender") and Jive Communications, Inc. ("Borrower").

### RECITALS

Borrower represents and warrants that Schedules A, B, and C attached hereto set forth any and all intellectual property rights in connection with which Borrower has registered or filed an application with either the United States Patent and Trademark Office or the United States Copyright Office, as applicable. This Agreement may be executed in two or more counterparts, each of which shall be deemed an original but all of which together shall constitute the same instrument.


