**RELEASE OF TRADEMARK SECURITY INTEREST**

THIS RELEASE OF TRADEMARK SECURITY INTEREST dated as of October 18, 2010 (this "**Release**") is made by Credit Suisse AG, as Collateral Agent (the "**Collateral Agent**") acting for the benefit of the Secured Parties. Capitalized terms used in this Agreement and not otherwise defined herein have the meanings specified in the Existing Credit Agreement or the Security Agreement, as applicable, referred to below.

A. Reference is made to the Credit Agreement, dated as of April 19, 2007 (as amended, supplemented or otherwise modified through the date hereof, the "**Existing Credit Agreement**"), among Sun Healthcare Group, Inc., a Delaware corporation (the "**Borrower**"), the Lenders from time to time party thereto, and Credit Suisse AG, as administrative agent (in such capacity, the "**Administrative Agent**") and Collateral Agent.

B. Reference is made to the Guarantee and Collateral Agreement, dated as of April 12, 2007, as supplemented by Supplement No. 1 dated as of October 23, 2008 and Supplement No. 2 dated as of October 26, 2009 (as further amended, supplemented or otherwise modified through the date hereof, the "**Security Agreement**"), among the Borrower, the Subsidiaries of the Borrower from time to time party thereto and the Collateral Agent. Pursuant to the Security Agreement, the Borrower, CareerStaff Unlimited, Inc., a Delaware corporation ("**CareerStaff**"), Sunmark of New Mexico, Inc., a New Mexico corporation ("**Sunmark**") and SolAmor Hospice Corporation, a Delaware corporation ("**SolAmor**" and, together with CareerStaff and Sunmark, the "**Trademark Grantors**"), entered into a Trademark Security Agreement dated as of April 19, 2007 (together with all amendments and modifications, if any, from time to time thereafter made thereto, the "**Trademark Security Agreement**"), pursuant to which the Trademark Grantors granted a security interest to the Collateral Agent, for the benefit of the Secured Parties, in, among other things, all right, title and interest of the Trademark Grantors in the trademarks set forth on Schedule I hereto (the "**Trademarks**"), which security interest was recorded with the United States Patent & Trademark Office as of April 25, 2007 at Reel/Frame 003518/0452.

C. In connection with the repayment of all Indebtedness and the termination of all Commitments under the Existing Credit Agreement, and the release of security interests under the Loan Documents, the Trademark Grantors have informed the Collateral Agent of their desire to obtain the release of all right, title and interest of the Collateral Agent, the Secured Parties and each other grantee or beneficiary in and to the Trademarks granted under the Trademark Security Agreement.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby releases all right, title and interest (including, without limitation, security interests) of the Collateral Agent and the Secured Parties in and to the Trademarks. The Collateral Agent hereby assigns, transfers and sets over to the Trademark Grantors all right, title and interest that the Collateral Agent and the Secured Parties

may have in or to the Trademarks under the Security Agreement and the Trademark Security Agreement, together with the goodwill of the business symbolized by such Trademarks.

The Collateral Agent agrees to perform all further acts and execute and deliver, at the Borrower's expense, all further documents and/or instruments that may be necessary to carry out the provisions of this Release. To the extent that any other filings with any other governmental authority have been made with respect to any of the Trademarks, the Collateral Agent will execute and deliver, at the Borrower's expense, a reasonable release or other instrument that will terminate any such filing and/or release any interests conveyed therein. Any execution and delivery of documents or instruments, including this Release, shall be without recourse to or warranty by the Collateral Agent.




