INTELLECTUAL PROPERTY ASSIGNMENT

THIS INTELLECTUAL PROPERTY ASSIGNMENT (the "IP Assignment") is entered into as of July 14, 2003 and is effective as of the Effective Time by and between Fiserv, Inc., a Wisconsin corporation ("Fiserv"), Fiserv PAR, Inc., a Wisconsin corporation ("Buyer"), Electronic Data Systems Corporation, a Delaware corporation ("EDS"), EDS Resource Management Corporation, a Delaware corporation ("ERMC") and EDS Information Services LLC, ("EIS") (EDS, ERMC, and EIS, each a "Seller" and together "Sellers").

W I T N E S S E T H:

WHEREAS, Sellers, Buyer and Fiserv are parties to an Asset Purchase Agreement dated as of July 11, 2003 (the "Asset Purchase Agreement") pursuant to which Buyer has agreed, upon the terms and conditions set forth therein, to purchase, acquire and accept the Transferred Assets;

WHEREAS, Sellers have agreed to sell, transfer, convey, assign and deliver to Buyer the Transferred Assets in accordance with the terms of the Asset Purchase Agreement;

NOW, THEREFORE, in consideration of the promises, covenants and agreements contained herein and other good and valuable consideration (the receipt and sufficiency of which are hereby acknowledged by each of the parties), the parties hereto hereby agree as follows:

1. Definitions. Each capitalized term in this IP Assignment shall have the same meaning as is ascribed to such term in the Asset Purchase Agreement, unless otherwise specified herein. In the event that there exists any conflict or difference between any of the terms and conditions hereof and any of the terms and conditions of the Asset Purchase Agreement, the Asset Purchase Agreement will control.

2. Conveyance and Assignment. Sellers hereby sell, transfer, convey, assign, and deliver all right, title and interest in and to the Transferred Trademarks and Transferred Copyrights, including those trademarks and trademark registrations, common law trademarks, service mark registrations and common law service marks, copyrights and trade names listed on Schedule A, together with the goodwill of the business associated therewith, to Buyer and Buyer does hereby purchase, acquire and accept all right, title and interest in and to the Transferred Trademarks and Transferred Copyrights, including those trademarks and trademark registrations, common law trademarks, service mark registrations and common law service marks, copyrights and trade names listed on Schedule A, together with the goodwill of the business associated therewith, on the terms and conditions as set forth in the Asset Purchase Agreement.


