RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of *November 12*, 2010 ("Effective Date") by and between ANN'S HOUSE OF NUTS, INC., a Maryland corporation, with its principal office at 9212 Berger Road #300, Columbia, Maryland 21046 ("Grantor"), and WELLS FARGO CAPITAL FINANCE, LLC, (formerly Wells Fargo Foothill, LLC), a Delaware limited liability company, with its principal office at One Boston Place, 18th Floor, Boston, Massachusetts 02108 ("Grantee").

WHEREAS, pursuant to the terms and conditions of that certain trademark security agreement by and between Grantor and Grantee dated July 2, 2008 (the "Trademark Security Agreement"), Grantor granted to Grantee a continuing security interest in and to all of Grantor's right, title and interest in and to, *inter alia*, all of the trademarks, and registrations of and applications to register the foregoing, and all of the trade names and assumed names owned by Grantor (collectively, the "Trademarks"), including, without limitation, the United States trademark registrations and applications set forth on Schedule A attached hereto, and the foreign trademark registrations and applications set forth on Schedule B attached hereto, in each case, together with the goodwill associated therewith;


WHEREAS, Grantor has paid all of its outstanding indebtedness to Grantee.


