Assignment of entire interest from Steelcase Inc. to Steelcase Development Inc., as evidenced by the official document recorded on August 10, 1999 at Reel/Frame 1936/0225;

Change of name from Steelcase Development Inc. to Steelcase Development Corporation , as evidenced by the official document recorded on September 27, 2007 at Reel/Frame 3629/0368; and

Merger of Steelcase Development Corporation into Steelcase Inc., as evidenced by the official document recorded on September 17, 2010 at Reel/Frame 4280/0160.

Shopko Stores, Inc. ("Shopko") is not and has not been affiliated with Steelcase Inc. or any predecessor through this chain of title.


Previously recorded documents by Shopko located at Reel/Frame 3243/0760 and 3247/0062, and recorded on January 11, 2006 and January 16, 2006, respectively, were submitted with incorrect information which led to the erroneous and improper recording against the subject registration.

As evidenced by the chain of title above, title of the subject registration stands in the name of Steelcase Inc., and the chain of title for the subject registration should not be considered altered by the incorrect assignments by Shopko.
