In the event of any conflict or inconsistency between the terms of this Assignment and the terms of the Transfer Agreement, the terms of the Transfer Agreement will prevail. Nothing contained herein will be deemed to alter, modify, expand or diminish the terms of the Transfer Agreement.

This Assignment will be governed by and construed in accordance with the laws of the State of Illinois, without giving effect to any law or rule that would cause the laws of any jurisdiction other than the State of Illinois to be applied.

This Assignment may be executed in two or more counterparts, each of which will be deemed to be an original copy of this Assignment but all of which, when taken together, will constitute one and the same agreement.

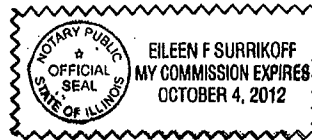

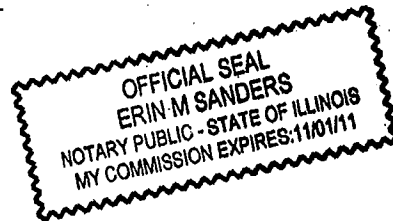
