## RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

WHEREAS, by that certain Term Note Security Agreement dated as of October 2, 2009 ("Security Agreement"), originally recorded in the Trademark Assignment Branch of the United States Patent and Trademark Office ("PTO") at Reel/Frame 4205/884, Signix, Inc., a Delaware corporation with an address at 1203 Carter Street, Chattanooga, Tennessee 37402 (the "Company"), granted to John Tally Johnston, III, J. Sites, Jr., and Neill Griffin Sites (collectively the "Purchasers"), a security interest in and lien upon the Company's trademarks, services marks and related registrations and applications (the "Trademarks"), together with the goodwill and assets of the business symbolized by such Trademarks and all actions for infringement concerning the foregoing including the right to sue for and to recover and retain all damages and profits arising from past infringements, identified in the attached Schedule A;


