BETWEEN:-

- (1) CARR & DAY & MARTIN LIMITED (formerly known as Quay Equestrian Limited) of Docklands, Dock Road, Lytham, Lancashire, FY8 5AQ ("Assignor"); and
- (2) GIBRALTAR (UK) LTD of, 1 Clifton Fields, Lytham Road, Clifton, Preston, PR4 0XG ("Assignee")

WHEREAS:

- (A) The Assignor is the proprietor of the two Trade Mark Registrations set out in the Schedule (referred to as the "Trade Marks");
- (B) The Assignor has agreed with the Assignee that the Trade Marks should be assigned to the Assignee for the consideration hereafter mentioned with effect from the date of this Assignment.

NOW THIS AGREEMENT WITNESSES as follows:

1. ASSIGNMENT

In pursuance of a consideration of £1 (One Pound Sterling), the receipt and sufficiency of which the Assignor hereby acknowledges, as of the date of this document the Assignor assigns unto the Assignee with full title guarantee all rights, title and interest in the Trade Marks including

- 1.1 All the property right title and interest in the Trade Marks including all statutory and common law rights connected solely with the use of the Trade Marks therewith and the right to sue for past infringements and to retain any damages obtained as a result of such action; and
- 1.2 The goodwill attaching solely to the Trade Marks as has been used or registered by the Assignor.

2. CONTRACTS (RIGHTS OF THIRD PARTIES) ACT 1999

Except as expressly provided in this Assignment, a person who is not a party to this Assignment shall have no rights under the Contracts (Rights of Third Parties) Act 1999 to rely upon or enforce any term of this Assignment provided that this does not affect any right or remedy of the third party which exists or is available apart from that Act. No party may declare itself as a trustee of the rights under this Assignment for the benefit of any third party save as expressly provided in this Assignment.

3. FURTHER ASSURANCE



4. LAW AND JURISDICTION

This Assignment shall be governed by and construed in accordance with the laws of England. The parties hereby submit to the exclusive jurisdiction of the High Court of England in relation to any dispute or claim arising out of, or in connection with, this Assignment.
