**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Agreement") dated as of November 15, 2010, from Citizens Bank, a Michigan banking corporation, whose address is 28001 Cabot Drive, Suite 250, Novi, Michigan 48377 ("Citizens Bank").

WITNESSETH:

WHEREAS, in connection with the Intellectual Property Security Agreement and Collateral Assignment dated December 8, 2003 ("IP Security Agreement"), GMAC Commercial Finance LLC was granted a security interest in all of its right, title and interest in, to and under all Intellectual Property (as defined in the Security Agreement) from Romeo-RIM, Inc. ("Grantor");

WHEREAS, the IP Security Agreement was recorded in the Trademark Assignment Division of the United States Patent and Trademark Office on December 30, 2003 at Reel 2890 and Frame 0085;

WHEREAS, pursuant to the Assignment of Intellectual Property Security Agreement and Collateral Assignment dated May 18, 2007 ("Assignment") the IP Security Agreement was assigned to Citizens Bank;

WHEREAS, the Assignment was recorded in the Trademark Assignment Division of the United States Patent and Trademark Office on June 1, 2007 at Reel 3553 and Frame 0321 and on September 17, 2007 at Reel 3622 and Frame 0179 as a corrective assignment; and

WHEREAS, Citizens Bank now wishes to release its liens on, and security interests in, the Trademarks (as set forth on Schedule A attached hereto).

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Agreement, the Agent hereby states as follows:

1. Release of Security Interest. Citizens Bank hereby terminates, releases and discharges all of its security interest in the Trademarks, and reassigns any and all right, title and interest that it may have in or to the Trademarks to Grantor. This Agreement does not terminate, release or discharge the Citizens Bank security interest in any Intellectual Property of any grantor other than the Trademarks shown on Schedule A.

2. Recordation. Citizens Bank or its authorized agent will record this Agreement with the United States Patent and Trademark Office.

3. Governing Law. This Agreement and the rights and obligations of the parties under this agreement shall be governed by, and construed and interpreted in accordance with, the law of Michigan, but giving effect to federal laws applicable to national banks.
