RELEASE OF TRADEMARK SECURITY AGREEMENT

This Release of Trademark Security Agreement is made as of November 19, 2010 by THE CIT GROUP/BUSINESS CREDIT, INC., a New York corporation, with an address of 30 South Wacker Drive, 30th Floor, Chicago, Illinois 60606 ("Secured Party").

WHEREAS, Decorative Panels International, Inc., a Delaware corporation ("Debtor"), granted a security interest in and lien upon certain trademarks, trade names trade styles, service marks and other intellectual property of Debtor to Secured Party as set forth in that certain Trademark Security Agreement dated as of May 21, 2004, by and between Debtor and Secured Party, and reaffirmed pursuant to that certain Reaffirmation of Trademark Security Agreement dated as of September 5, 2007 (collectively, the "Security Agreement");

WHEREAS, an executed copy of the Security Agreement was recorded in the United States Patent and Trademark Office ("USPTO") on July 16, 2004 at Reel No. 003008, Frame No. 0042, with respect to the registered trademarks listed on Schedule A attached hereto and made a part hereof (the "Trademarks");

WHEREAS, Debtor has requested that Secured Party release its interest in the Collateral (as defined in the Security Agreement) of Debtor, including, without limitation, Secured Party's interest in the Trademarks;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Secured Party hereby:

1. terminates and releases any and all liens, security interests, right, title and interest of Secured Party granted pursuant to the Security Agreement in the Collateral (as defined in the Security Agreement) of Debtor and in the Trademarks, without recourse or representation or warranty, express or implied, of any kind;
2. agrees that any power of attorney or similar rights granted by Debtor to Secured Party under the Security Agreement is terminated; and
3. authorizes and requests that the USPTO note and record the existence of the release hereby given.
