**Re: Request for Release of Lien**

Ladies and Gentlemen:

Reference is made to (i) that certain Revolving Credit, Term Loan and Security Agreement dated September 29, 1999 (as amended, modified and/or supplemented, the "Credit Agreement"), by and among American Rice, Inc. (the "Borrower"), the lenders party thereto (the "Lenders") and GMAC Commercial Credit, LLC, as agent for the Lenders (the "Agent") and (ii) that certain Leasehold Deed of Trust, Absolute Assignment of Leases and Rents, Security Agreement and Fixture Filing dated September 29, 1999 and recorded on October 1, 1999 as Instrument No. 44937 in the Official Records of Brazoria County, Texas (the "Deed of Trust"). 


