RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (the "Release") is made effective as of November 30, 2010, by and from BEAR STEARNS CORPORATE LENDING INC., for itself and as Administrative Agent for the Secured Parties (the "Administrative Agent") to BRAVO HEALTH, INC., a Delaware corporation (the "Grantor") as follows:

WHEREAS, on August 1, 2007, the Grantor and the Administrative Agent entered into a Guarantee and Collateral Agreement (the "GCA") and a Grant of Security Interest in Trademark Rights (the "Grant");

WHEREAS, pursuant to the GCA and the Grant, the Grantor granted to the Administrative Agent on behalf of the Secured Parties, among other collateral, a continuing security interest in all of the Grantor's right, title and interest, including goodwill, in, to and under the United States Trademarks (including, without limitation, those items listed on the attached Schedule A (the "Marks");

WHEREAS, the Grant was recorded in the United States Patent & Trademark Office on August 10, 2007 at reel/frame 3599/0015; and

WHEREAS, the Administrative Agent wishes to release the entirety of its security interest in the Marks.

NOW THEREFORE, in exchange for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby terminates, discharges and releases all right, title and interest (including, without limitation, security interests) it may have in the Marks, which shall hereby cease and become void, and retransfers and reassigns any and all right, title and interest it may have in and to the Marks without recourse to Grantor.

The Administrative Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect this Release.
