NUNC PRO TUNC TRADEMARK ASSIGNMENT

Assignor shall provide to the Assignee, its successors, assigns or other representatives, such prompt cooperation and assistance as may be reasonably required in connection with effectuating the purposes of this Assignment (including by executing and delivering affidavits, declarations, oaths, exhibits, assignments, powers of attorney and other documentation to perfect the Assignee's right, title and interest in, to and under the Mark).

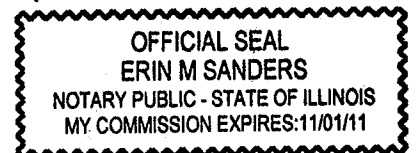
