## TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT ("Assignment") is by and between WESTERN ATLAS INTERNATIONAL INC., a corporation formed in accordance with the laws of Delaware (the "Assignor"), and BAKER HUGHES INCORPORATED, a corporation formed in accordance with the laws of Delaware (the "Assignee").

WHEREAS, as of December 30, 1999, Assignor was the owner of all right, title and interest in and to the trademarks and the corresponding registrations and/or applications for registration set forth on Exhibit 1 (collectively, the "Trademarks"), together with the goodwill of the business connected with and symbolized by the Trademarks; and

WHEREAS, Assignee, through that certain Omnibus General Indenture dated December 31, 1999 and that certain Agreement for the Assignment of Legal Title in BHI Subsidiary IP Rights dated December 31, 1998, acquired all right, title and interest in and to the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are acknowledged, the parties hereby agree as set forth below.

Assignor hereby confirms the sale, assignment, transfer and conveyance to Assignee on December 31, 1998 of the entire right, title, interest in and to the Trademarks in the United States, together with the goodwill of the business connected with and symbolized by the Trademarks (including, without limitation, the right to renew any registrations included in the Trademarks, the right to apply for trademark registrations within or outside the United States based in whole or in part upon the Trademarks, and any priority right that may arise from the Trademarks), the same to be held and enjoyed by Assignee as fully and entirely as said interest could have been held and enjoyed by Assignor had a sale, assignment, transfer and conveyance not been made.

Assignor confirms the authorization of the Commissioner of Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office to record the transfer of the registrations and/or applications for registration set forth on Exhibit 1 to Assignee as assignee of Assignor's entire right, title and interest therein. Assignor agrees to further execute any documents reasonably necessary to effect this assignment or to confirm Assignee's ownership of the Trademarks.

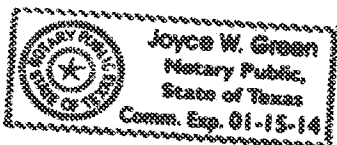
