PARTIAL RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS PARTIAL RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Release") is made as of December 7, 2010 (the "Effective Date") by Deutsche Bank Trust Company Americas, as administrative agent (in such capacity, the "Administrative Agent"), on behalf of itself and the other Secured Parties for the benefit of The Topps Company, Inc. (the "Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Guarantee and Collateral Agreement, dated as of October 12, 2007, between Tornante-MDP Joe Holding LLC, Tornante-MDP Joe Acquisitions Corp., the Grantor, the Subsidiary Guarantors party thereto and the Administrative Agent (the "Security Agreement"), the Grantor pledged, assigned and granted to the Administrative Agent a continuing security interest in all of its right, title and interest in and to certain collateral including the trademarks and trademark applications set forth on Schedule I (collectively, the "Trademarks") and the goodwill associated with the Trademarks;

WHEREAS, the Security Agreement relating to the Trademarks was recorded with the Trademark Division of the U.S. Patent & Trademark Office on November 8, 2007, at Reel 003657 and Frame 0319 and a supplement to the Security Agreement relating to the Trademarks was recorded with the Trademark Division of the U.S. Patent & Trademark Office on February 8, 2008, at Reel 003712 and Frame 0227;

WHEREAS, the Grantor desires to transfer certain of its assets subject to the liens of the Security Agreement to Topps Properties, Inc., its wholly-owned subsidiary, including the Trademarks, and has requested that the Administrative Agent release its interest in the Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby terminates, cancels, re-pledges, reassigns and releases any and all security interests it has against the Trademarks and goodwill associated with the Trademarks without representation, warranty or recourse of any kind whatsoever.

If and to the extent the Administrative Agent has acquired any right, title or interest to any of the Trademarks or the goodwill associated with the Trademarks, it hereby assigns and transfers such rights, title or interest to the Grantor.

Other than the foregoing release of the Trademarks, made by the Administrative Agent on behalf of itself and the other Secured Parties for the benefit of the Grantor on or around the date hereof, the Administrative Agent hereby confirms its lien on and security interest in all right, title and interest in and to all other Collateral pledged to it under the Security Agreement.

Capitalized terms used but not defined herein shall have the meaning set forth in the Security Agreement.
