ASSIGNMENT OF TRADEMARKS

3. Assignor further authorizes the commissioner of Patents and Trademarks of the United States and any official of any country or countries foreign to the United States whose

duty it is to record trademark registrations, applications and title thereto, to record the Mark and title thereto as the property of the Assignee, its successors, legal representatives and assigns in accordance with the terms of this instrument.

Now therefore, for good and valuable consideration, the receipt of which is hereby acknowledged, said CRYOVAC, INC. does hereby assign to the said SEALED AIR CORPORATION (US) all right, title and interest in and to the trademark and the goodwill of the Acquired Business symbolized thereby.
