Pursuant to Section 253 of the Delaware General Corporation Law, the undersigned corporation, organized and existing under and by virtue of the General Corporation Law of the State of Delaware, does hereby certify:

FIRST. The name of the surviving corporation is Praxair Surface Technologies, Inc., a Delaware corporation, and the name of the corporation being merged into this surviving corporation is Sermatech International Incorporated., a Pennsylvania corporation.

SECOND.
