RELEASE AND REASSIGNMENT OF PATENTS AND TRADEMARKS

This **RELEASE AND REASSIGNMENT OF PATENTS AND TRADEMARKS** dated December 3, 2010 is made by **ARES CAPITAL CORPORATION** (successor by merger to **ALLIED CAPITAL CORPORATION**), as Administrative Agent ("**Secured Party**").

RECITALS

A. NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:



(ii) All proceeds of the foregoing, including without limitation any claim by Pledgor against third parties for damages by reason of past, present or future infringement of any of the Patents and Trademarks or by reason of injury to the goodwill associated with any of the Patents and Trademarks, in each case together with the right to sue for and collect said damages.
