## **RELEASE OF AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT**

**RELEASE OF AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT**, dated as of September 20, 2010, by OBSIDIAN, LLC, as Collateral Agent (as defined below) for the benefit of the Secured Parties (as defined below) in connection with the Second Amended and Restated Second Lien Credit and Guaranty Agreement, dated as of December 31, 2007 (as amended, amended and restated, supplemented or otherwise modified and in effect from time to time, the "Credit Agreement") by and among EP MANAGEMENT CORPORATION (formerly known as EAGLEPICHER CORPORATION), a Delaware corporation (the "Borrower"), CERTAIN SUBSIDIARIES OF THE BORROWER (the "Guarantors"), the LENDERS PARTY THERETO FROM TIME TO TIME (the "Lenders"), OBSIDIAN, LLC, as Administrative Agent (together with its permitted successors in such capacity, the "Administrative Agent") and as Collateral Agent (together with its permitted successors in such capacity, the "Collateral Agent") and GENERAL ELECTRIC CAPITAL CORPORATION, as Documentation Agent. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Trademark Security Agreement (as defined below).

**WHEREAS**, the Grantors and the Collateral Agent entered into that certain Amended and Restated Trademark Security Agreement dated as of December 31, 2007 (the "Trademark Security Agreement"), which Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel 003748, Frame 0800 on March 28, 2008; and

**WHEREAS**, pursuant to the Trademark Security Agreement, the Grantors mortgaged, pledged and hypothecated to the Collateral Agent for the benefit of the Secured Parties, and granted to the Collateral Agent for the benefit of the Secured Parties a lien on and security interest in, all of the Trademark Collateral as collateral security for the full, prompt and complete payment and performance of the Secured Obligations.


The Collateral Agent, on behalf of the Secured Parties and in connection with the payment in full of all obligations and liabilities of the Borrower under the Credit Agreement, has agreed (i) to terminate and release all its security interest and all its right, title and interest in, to and under the Trademark Collateral, including, without limitation, those items identified on Exhibit A attached hereto, all goodwill of the business connected with the use of, and symbolized by, each Trademark; and all Proceeds of the foregoing, including, without limitation, any claim by a Grantor against third parties for past, present or future (x) infringement or dilution of any Trademark Collateral or (y) injury to the goodwill associated with any Trademark Collateral (collectively, the "Released Trademarks"), each of such Released Trademarks being owned by and registered in the name of such Grantor that granted a security interest therein to the Collateral Agent pursuant to the Trademark Security Agreement and (ii) to assign and transfer to each such Grantor all deeds, assignments and other instruments as may be necessary or proper to reassign, reconvey and re-vest in such Grantor the entire right, title and interest in such Released Trademark, as herein provided;

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, on behalf of the Secured Parties, hereby releases the

Grantors from the Trademark Security Agreement and assigns and transfers to each Grantor, without representation, warranty or recourse, all of the Collateral Agent's right, title and interest in and to each of the Released Trademarks in which such Grantor granted a security interest to the Collateral Agent pursuant to the Trademark Security Agreement, effective as of the date set forth above.
