TRADEMARK SECURITY AGREEMENT**



**KNOW ALL MEN BY THESE PRESENTS, THAT,** BANK OF AMERICA, N.A., a national banking association, having its principal office located at 135 South LaSalle Street, Mail Code IL-4-135-04-65, Chicago, Illinois 60603 (the “Secured Party”), does hereby release all of its right, title and interest under that certain Trademark Security Agreement dated October 31, 2008 made by HENNIGES AUTOMOTIVE HOLDINGS, INC., a Delaware corporation, having its principal office located at 900 East Whitcomb Avenue, Madison Heights, Michigan, 48071 (“Grantor”) in favor of Secured Party, which was recorded with the U.S. Patent and Trademark Office on December 22, 2008 at Reel No. 3907, Frame No. 0664 (the “Trademark Security Agreement), and Secured Party hereby terminates, releases and discharges all of its right, title and interest in and to (i) the Trademarks (as defined in the Trademark Security Agreement), including, without limitation, those Trademarks set forth in Schedule A attached hereto, in each case together with (ii) all proceeds and products of the Trademarks, (iii) the goodwill of the businesses with which the Trademarks are associated, and (iv) all causes of action arising for infringement of any of the Trademarks or unfair competition regarding the same and all damages awarded therefrom.
