**TERMINATION OF SECURITY INTEREST IN
TRADEMARKS**

THIS TERMINATION OF SECURITY INTEREST IN TRADEMARKS (the "Termination"), dated as of December 10, 2010, is executed by Canyon Capital Advisors LLC, in its capacity as agent for the lenders party to the Credit Agreement referred to below (in such capacity, together with its successors and assigns, the "Agent"), in favor of Hawaiian Airlines, Inc. and Hawaiian Holdings, Inc. (collectively, jointly and severally, "Grantors", and each individually "Grantor"). (Capitalized terms used herein but not herein defined have the meanings assigned to such terms in the Credit Agreement.)

Recitals

A. In connection with that certain Credit Agreement, dated as of June 2, 2005 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), by and among Grantors, Agent and the lenders party thereto from time to time (such lenders, together with their respective successors and permitted assigns, each a "Lender" and collectively, the "Lenders"), Grantors and Agent entered into that certain Trademark Security Agreement, dated as of June 1, 2005 (as amended, restated, supplemented or otherwise modified from time to time, the "Agreement"), wherein Grantors granted to Agent, for the benefit of the Lenders, a security interest in all Trademark Collateral (as hereinafter defined) of the Grantors.

B. The Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on June 3, 2005, at Reel/Frame 3126/0740 to evidence the security interest granted under the Agreement.

C. Grantors have satisfied in full all of the outstanding Obligations under the Credit Agreement, and in connection therewith, Agent has agreed to terminate and release its security interest in the Trademark Collateral (as defined below) as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent hereby agrees as follows:

1. Agent expressly terminates and releases its security interest and all right, title and interest in, to and under the following, whether presently existing or hereafter created or acquired (collectively, the "Trademark Collateral"):

(a) all of its Trademarks including those registrations and/or applications referred to on Schedule I hereto;

(b) all reissues, continuations or extensions of the foregoing;

(c) all goodwill of the business connected with the use of, and symbolized by, each Trademark; and

(d) all products and proceeds of the foregoing, including, without limitation, any claim by such Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or any Trademark licensed under any Intellectual Property License or (ii) injury to the goodwill associated with any Trademark or any Trademark licensed under any Intellectual Property License.

2. Agent hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested by the Grantors in order to more fully and effectively carry out the purposes of the Termination at the Grantors' sole cost and expense.
