NOTICE OF SECURITY INTEREST

Terry's Tire Town, Inc., an Ohio corporation (together with its successors and permitted assigns, "Debtor"), and The Huntington National Bank (together with its successors and assigns, "Secured Party"), are parties to a certain Intellectual Property Security Agreement dated November 23, 2010 (the "Security Agreement").
