ASSIGNMENT OF TRADEMARK AND COPYRIGHTS

This ASSIGNMENT OF TRADEMARK AND COPYRIGHTS is made this 14th day of December, 2010 by and between Collins Bus Corporation, a Kansas corporation ("Assignor") and North American Bus Industries, Inc. an Alabama corporation ("Assignee").

The terms and conditions of that Agreement having been fully performed by the parties thereto, Assignor, successor to Mobile Tech Corporation now assigns its interest in the Steplift and associated trademark to Assignee, successor to Optima Bus Corp.

Assignor hereby grants, conveys and assigns to Assignee all right, title and interest to the design for a wheelchair lift for passenger buses known as the Steplift, including all intellectual property associated with Steplift and all tooling, jigs and fixtures used in the manufacture of Steplift, possession of which have already been transferred to Assignee, and all right, title and interest in and to the STEP-LIFT trademark, Serial Number 74080285, Registration Number 1644978, together with the good will of the business symbolized by the Mark, including all common law rights, and all claims for damages by reason of infringement of the Mark.

Assignor hereby grants, conveys and assigns to Assignee all right, title, and interest in any copyrights it owns in all Steplift documentation including all renewals and extensions thereof, including any and all derivations, modifications, changes, translations, revisions, elaborations, adaptations or transformations of the original works, and including all claims for damages by reason of infringement of the works.
