ARTICLES OF AMENDMENT
OF

SUNQUEST INFORMATION SYSTEMS, INC

Pursuant to Sections 1915 of the Pennsylvania Business Corporation Law, the undersigned corporation hereby submits these Articles of Amendment for the purpose of amending its Amended and Restated Articles of Incorporation:

1. The name of the corporation is: SUNQUEST INFORMATION SYSTEMS, INC.
2. The address of the registered office of the corporation (which is located in Cambria County) is:

1407 Eisenhower Boulevard, Suite 200
Johnstown, PA 15904
3. The corporation was originally incorporated on September 10, 1979 pursuant to the Arizona Business Corporation Act. Effective January 1, 1996, pursuant to 15 Pa.C.S. § 4161, the corporation was domesticated in Pennsylvania and became subject to the Pennsylvania Business Corporation Law of 1988, as amended.
4. The original date of its incorporation in Arizona is September 10, 1979.
5. These articles of amendment will be effective upon filing.
6. These articles of amendment were adopted by the board of directors of the corporation in accordance with 15 Pa.C.S. § 1914(c).
7. The Amended and Restated Articles of Incorporation of Sunquest Information Systems, Inc. shall be amended by deleting the entire text of Article 1 thereof and substituting in its place the following:

"The name of the corporation is: MISYS HOSPITAL SYSTEMS, INC. (the "Corporation")."
