
WHEREAS, Assignee is desirous of acquiring all of Assignor's rights, title and interest in said trademark and application to register the same;

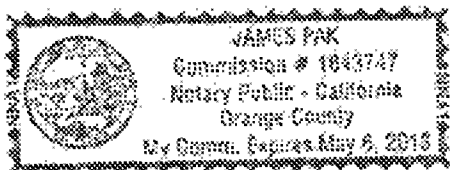

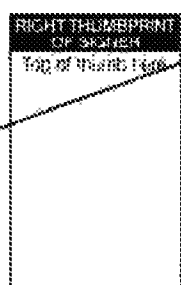
