PURSUANT TO AN ASSET PURCHASE AGREEMENT

WHEREAS pursuant to the Asset Purchase Agreement dated as of February 22, 2010 between AVIVA INC., a company existing under the laws of the Province of Québec (the "**Seller**"), 4549589 CANADA INC., a corporation existing under the laws of Canada (the "**Buyer**") and Valerio Lanzieri, the Buyer agreed to purchase from the Seller substantially all of the assets, properties, rights and undertaking of the business of the Seller, including the Intellectual Property.

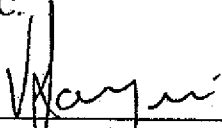
1. **FOR VALUE RECEIVED**, the Seller assigns and transfers to the Buyer:
 - 1.1 all of the Seller's right, title and interest in and to the trade-marks owned by the Seller, all of which are listed in Schedule "A", and any associated applications or registrations, along with the goodwill associated with those trade-marks; and
 - 1.2 any copyright in the designs forming part of those trade-marks, as applicable;(collectively, the "**Intellectual Property**").
2. The Buyer accepts the assignments set out in paragraph one above.
3. The recording or registration of the assignments granted under this assignment will be in the sole discretion of and will be the sole responsibility of the Buyer and at Buyer's sole cost; however, the Seller agrees to execute any instruments necessary and to do all things necessary to ensure the Buyer can record and register the assignments.
4. The Seller represents and warrants to the Buyer that:
 - 4.1 the Intellectual Property is owned solely and exclusively by the Seller;
 - 4.2 to the best of the Seller's knowledge and belief the Intellectual Property is distinctive of the Seller's goods and services; and
 - 4.3 the Seller has all right and authority to make these assignments.
5. This Agreement will enure to the benefit of and be binding upon the parties and their respective successors and assigns.

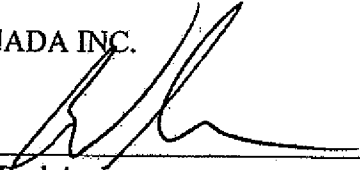
