RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of December 16, 2010 ("Effective Date") by UBS AG, STAMFORD BRANCH, AS COLLATERAL AGENT, a Swiss bank with its principal office at 677 Washington Boulevard, Stamford, Connecticut 06901 ("Grantee"), in favor of SUNQUEST INFORMATION SYSTEMS, INC., a Pennsylvania corporation with its principal office at 250 S. Williams Boulevard, Tucson, Arizona 85711 ("Grantor"). Capitalized terms used in this Release, but not otherwise defined herein, have the meaning set forth or incorporated by reference in the Trademark Security Agreements (as defined below).

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement by and between Grantor and Grantee, dated September 14, 2010 and that certain Supplement No. 1 to the Trademark Security Agreement by and between Grantor and Grantee, dated January 23, 2009 (the "Trademark Security Agreements"), Grantor pledged and granted to Grantee for the benefit of the Secured Parties a lien on and security interest in and to all of Grantor's right, title and interest in, to and under all of Trademarks of the Grantor, all Goodwill associated with such Trademarks, and all Proceeds of any and all of the foregoing, including, without limitation, the trademark applications and registrations set forth on Schedule A attached hereto (collectively, the "Trademark Collateral");

WHEREAS, Grantor and Grantee entered into the Trademark Security Agreements pursuant to the terms and conditions of that certain Security Agreement by and between Pledgor and Collateral Agent dated October 11, 2007 (the "Security Agreement");

WHEREAS, the Trademark Security Agreements were recorded with the United States Patent and Trademark Office ("PTO") on September 22, 2010 at Reel/Frame: 4283/0062 and on January 29, 2009, at Reel/Frame: 3926/0936;

WHEREAS, Grantee has agreed to release its security interest in all right, title and interest of Grantee in and to the Trademark Collateral, including, without limitation, the trademark applications and registrations set forth on Schedule A attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Trademark Security Agreements, the Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Trademarks.




