## TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of December 14, 2010, is made by Wells Fargo Bank, National Association, successor-by-merger to Wachovia Bank, National Association, as Administrative Agent (the "Secured Party").

**WHEREAS**, pursuant to that certain First Lien Security Agreement, dated March 29, 2006, by and among the Secured Party, Bresnan Communications, LLC (the "Grantor") and certain other parties thereto, Grantor has granted a security interest in certain personal property to the Secured Party, including without limitation a security interest in certain trademarks, trademark applications, and/or trademark licenses ("Trademarks");

2. all goodwill of the business connected with the use of, and symbolized by, each Trademark; and
3. all products and proceeds of the foregoing, including, without limitation, any claim by the Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or (ii) injury to the goodwill associated with any Trademark.
