**RELEASE OF SECURITY INTEREST  
IN UNITED STATES TRADEMARKS**

This Release (this "Release"), effective as of December 17, 2010, is granted by Deutsche Bank Trust Company Americas, as Collateral Agent ("Collateral Agent"), with principal offices at 60 Wall Street, New York, New York 10005, to RAI II, LLC, (formerly known as National Renal Alliance, LLC), a Delaware limited liability company with principal offices at 115 East Park Drive, Suite 300, Brentwood, TN 37027 ("Grantor"), as follows:

**W I T N E S S E T H**

WHEREAS, the Grantor has heretofore granted to the Collateral Agent a security interest in certain United States trademark registrations and trademark applications more particularly set forth in Schedule A attached hereto (collectively, "Marks") to secure the Obligations (as such term is defined in the Guarantee and Collateral Agreement, dated June 3, 2010, between the Collateral Agent, the Grantor and the other parties thereto (as amended, modified, restated and/or supplemented from time to time, the "Collateral Agreement")); and

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Collateral Agent hereby releases, discharges, quit claims, and relinquishes unto the Grantor any and all right, title, and interest in and to the Marks (and any proceeds, claims or goodwill associated with, or arising from, the Marks), and more particularly, the security interest in the Marks, granted to the Collateral Agent by the Grantor pursuant to the Collateral Agreement and the Grant of Security Interest in United States Trademarks, dated as of June 3, 2010, by the Grantor in favor of the Collateral Agent, which security interest was duly recorded on June 15, 2010, at Trademark Reel 4224, Frame 0761 in the United States Patent and Trademark Office. The Collateral Agent hereby authorizes the Grantor or its counsel to file an executed copy of this Release with the United States Patent and Trademark Office and agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts

as may be reasonably necessary or requested by the Grantor to effect such release of the security interests in the Marks, in each case, without recourse and without representation or warranty of any kind (either express or implied). All of the foregoing shall be at the expense of the Grantor.
