NUNC PRO TUNC ASSIGNMENT

WHEREAS, GetThere, Inc., a Delaware corporation having its principal office at 3150 Sabre Drive, Southlake Texas 76092 (hereinafter "ASSIGNOR"), had acquired by name change from GetThere.com, Inc. on June 26, 2000 and was using the mark INTERNET TRAVEL NETWORK & Design, the subject of U.S. Trademark Registration No. 2,857,113 issued June 29, 2004, by the U.S. Patent and Trademark Office (hereinafter, the "Mark"), and


