**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of December 14, 2010, is made by NexBank SSB, as Second Lien Administrative Agent (the "Secured Party").

3. all products and proceeds of the foregoing, including, without limitation, all income, royalties, and any claim by the Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or (ii) injury to the goodwill associated with any Trademark and any damages or payments with respect thereto.
