**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "**Release**"), dated as of December 6, 2010, is made by **GENERAL ELECTRIC CAPITAL CORPORATION**, as agent (the "**Agent**"), under the Amended and Restated Credit Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement).

**WHEREAS**, in connection with that certain Amended and Restated Credit Agreement, dated as of June 27, 2008 (as amended, restated, supplemented or otherwise modified from time to time, and together with all general security agreements, trademark security agreements and copyright security agreements entered into in connection therewith or in connection with prior versions thereof, the "**Credit Agreement**"), among **ASCEND LEARNING, LLC (f/k/a JBP Midco, LLC)** (the "**Borrower**"), the other Credit Parties signatory thereto, the Agent, and the Lenders signatory thereto from time to time (each individually a "**Lender**," and collectively, the "**Lenders**"), the Lenders made credit extensions to the Borrower;

**WHEREAS**, in connection with the Credit Agreement, and pursuant to those certain agreements described on Annex I attached hereto (collectively, the "**Security Agreements**"), certain of the Credit Parties granted security interests in certain intellectual property owned by such Credit Parties, including those listed on Annex I attached hereto (collectively, the "**Intellectual Property Collateral**"); and

**WHEREAS**, the Security Agreements were recorded in the U.S. Patent and Trademark Office or the Copyright Office, as applicable, on the dates and on the reels and frames set forth on Annex I hereto;

**NOW THEREFORE**, the Agent hereby **RELEASES**, without representation, recourse or warranty whatsoever, all of its security interest in the Intellectual Property Collateral, whether granted pursuant to the Security Agreements or any other agreement or document delivered in connection with the Credit Agreement, and the Collateral Agent hereby reassigns any and all such right, title and interest (if any) that the Agent may have in the Intellectual Property Collateral to the Credit Parties.

The Agent agrees, at the Borrower's and the other Credit Parties' expense, to cooperate with the Borrower and the other Credit Parties and to provide the Borrower and the other Credit Parties with the information and additional authorization reasonably required or desirable to effect the release of the Agent's security interest in the released collateral described herein.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
