The trademark database erroneously shows "Seko Enterprises, LLC, formerly known as Seko Worldwide, LLC" as the owner of trademark Regs. Nos. 1470985 and 2117536. The correct owner is Seko Worldwide, LLC.

On 01/30/2009, the Assignment Division recorded a Nunc Pro Tunc Assignment between Seko Customs Brokerage, Inc. (formerly USF Worldwide, Inc.) and Seko Enterprises, LLC, formerly known as Seko Worldwide, Inc. (Reel/Frame 3927/0360). The Nunc Pro Tunc Assignment's effective date is January 1, 2003.

After the January 1, 2003, effective date, Seko Worldwide, LLC, changed its name to Seko Enterprises, LLC (Reel/Frame 2887/0047, recorded 12/05/2003). Seko Enterprises, LLC, then assigned its rights to a "new" Seko Worldwide, LLC (Reel/Frame 3159/0944, recorded 09/15/2005). Since the assignment from Seko Enterprises, LLC, to Seko Worldwide, LLC, is the most recent conveyance in the chain of title, Seko Worldwide, LLC is the proper owner of trademark Regs. Nos. 1470985 and 2117536, and Seko Worldwide, LLC, asks that the trademark database be updated accordingly.

TRADEMARK ASSIGNMENT

Seko Customs Brokerage, Inc. formerly known as USF Worldwide, Inc., a Delaware corporation ("Assignor"), being the owner of the word marks "Seko" and "Seko Worldwide" (together, the "Marks") with United States Trademark Registration Nos. 1470985 (the "Seko Registration") and 2117536 (the "Seko Worldwide Registration"), in consideration of One Dollar (\$1.00) and other good and valuable consideration, receipt of which are hereby acknowledged, hereby sells, assigns, and transfers to Seko Enterprises, LLC formerly known as Seko Worldwide, LLC, an Illinois limited liability company, its successors and assigns, the entire right, title and interest in and to the Marks, the Seko Registration and the Seko Worldwide Registration together with the goodwill represented by the Marks.

The undersigned, William J. Wascher, declares: that he is the president of Assignor and is authorized to execute this Trademark Assignment on behalf of said corporation.

DECLARATION IN SUPPORT OF REQUEST FOR CORRECTION OF RECORDS

Pursuant to 28 U.S.C. §1746 and 37 C.F.R. §2.20, the undersigned declares as follows:

1. I am Manager of Seko Worldwide, LLC, a Delaware limited liability company that is presently the owner of record of United States Trademark Registration Nos. 1470985 (the "SEKO Registration") and 2117536 (the "SEKO WORLDWIDE" Registration). During all times relevant to the statements made in this Declaration, I was either manager or President of the following entities:

- Seko Enterprises, LLC, an Illinois limited liability company formerly known as Seko Worldwide, LLC; and
- Seko Customs Brokerage, Inc., a Delaware corporation formerly known at various times as USF Worldwide, Inc., USF Seko Worldwide, Inc., Seko Worldwide, Inc. and Seko Air Freight, Inc.

In addition, I am a member of Seko Enterprises, LLC, which, at the relevant times, was the controlling owner of Seko Customs Brokerage, Inc. I am authorized to make this declaration on behalf of Seko Worldwide, LLC, and all of the entities identified above.

2. All statements made herein are made on the basis of personal knowledge and on the records of the various entities listed above to which I have access.

3. Attached as Schedules A and B hereto are copies of excerpts from the online records of the Assignment Branch of the United States Patent and Trademark Office showing the title history for the SEKO Registration (Schedule A) and the SEKO WORLDWIDE Registration (Schedule B).

4. Schedules A and B show that a document was recorded at Reel/Frame 2642/0513 purporting to be an assignment of the entire interest and goodwill in and to the SEKO Registration and the SEKO WORLDWIDE Registration from Seko Air Freight, Inc. to Seko Worldwide, LLC, executed on December 23, 2002, but stated to be effective as of October 17, 2002. That assignment was executed and recorded in error. Seko Air Freight, Inc., the original registrant, had gone through several name changes and a merger, with the result that the rights and goodwill associated with the SEKO and SEKO WORLDWIDE Marks were held by USF Worldwide, Inc., as of October 30, 2002, when the rights and goodwill in and to the SEKO and SEKO WORLDWIDE Marks, including the U.S. Registrations, were assigned to Seko Worldwide, LLC, an Illinois limited liability company. The purported assignment from Seko Air

Freight, Inc. to Seko Worldwide, LLC executed on December 23, 2002, failed to take into consideration the intervening name changes and merger, and was therefore executed in error. On behalf of both Seko Air Freight, Inc. (the purported assignor) and Seko Worldwide, LLC (the purported assignee), I do hereby reject and repudiate this assignment and declare the same to be null and void.

5. Schedule B shows that a document was recorded at Reel/Frame 2791/0819 purporting to be an assignment of the entire interest and goodwill in and to the SEKO WORLDWIDE Mark, including the U.S. Registration, from USF Seko Worldwide, Inc. to Seko Air Freight, Inc., executed on July 11, 2003, but stated to be effective as of October 16, 2002. This assignment was executed and recorded in error. Seko Air Freight, Inc. and USF Seko Worldwide, Inc. are actually the same company, as a result of name changes that are already of record. On November 11, 1999, USF Seko Worldwide, Inc. merged into USF Worldwide, Inc. The purported assignment from USF Seko Worldwide, Inc. to Seko Air Freight, Inc. failed to take into consideration the intervening name changes, and was therefore executed in error. On behalf of both USF Seko Worldwide, Inc. (the purported assignor) and Seko Air Freight, Inc. (the purported assignee), which, as explained above, are one and the same legal entity, I do hereby reject and repudiate this assignment and declare the same to be null and void.

6. Attached are copies of two documents that are being recorded with the Assignment Branch concurrently with this Declaration. The first is confirmation from the Illinois Secretary of State that on November 11, 1999, USF Seko Worldwide, Inc., merged into name to USF Worldwide, Inc. The second is an assignment of USF Worldwide, Inc.'s entire interest in and to the SEKO Registration and SEKO WORLDWIDE Registration, together with the goodwill represented by those marks, to Seko Worldwide, LLC, effective as of January 1, 2003. I confirm on behalf of USF Worldwide, Inc. (formerly USF Seko Worldwide, Inc.) and Seko Worldwide, LLC, that this is the correct history of the ownership of these marks. I further confirm that the remainder of the ownership and assignment history after January 1, 2003 is correctly recorded.

7. Pursuant to TMEP 503.06(b), Seko Worldwide, LLC, Seko Enterprises, LLC and Seko Customs Brokerage, Inc. respectfully request that these errors be corrected in the Office records.

The undersigned being warned that willful false statements and the like are punishable by fine or imprisonment, or both, under 18 U.S.C. 1001, and that such willful false statements and the like may jeopardize the validity of the application or document or any registration resulting therefrom, declares that all statements made of his own knowledge are true; and all statements made on information and belief are believed to be true.
