WHEREAS, in connection with the Securities Purchase Agreements, the Assignee entered into the Security Documents under which, among other things, the Assignee granted to the Assignor a continuing security interest in all of the Assignee's rights, title and interest in, to and under the Intellectual Property listed on Schedule A hereto, in each case, whether then existing or thereafter created or acquired;
