**Resolution of the Shareholder  
Of

Pursuant to an Agreement dated September 2, 2010, retroactive to January 1, 2009, Shocker energy, Inc., a Colorado business corporation adopts the following resolution herein:

RESOLVED by the Shareholder of the Corporation as follows:

**Payment Bill Shepard.** Bill Shepard acknowledges the receipt of payment from Terry Smith in exchange for all of Bill Shepards' ownership interest in Shocker Companies.

**Payment Travis Shepard.** Travis Shepard acknowledges the receipt of payment from Terry Smith in exchange for all of Travis Shepards' ownership interest in shocker Companies.

**Payment Larry Shepard.** United States Trademark "Hand" logo, serial number 77648467 shall be transferred to Larry Shepard, to be owned by Larry Shepard individually in exchange for transferring all of Larry Shepards' ownership interest in shocker Companies to Terry Smith. Larry Shepard shall be responsible for subsequent costs attributable to this trademark.

**Trademark Licensing Agreement.** Larry Shepard further agrees to grant Shocker Companies a perpetual, paid up, royalty free license to use, reproduce, copy, promote, advertise, market and otherwise utilize the aforementioned trademark.

**Sale of Trademark(s).** If Larry Shepard or any successor in interest contemplate the sale of previously listed trademark, Shocker Energy, Inc. shall be notified in writing of contemplated sale and shall have a 30 day right of first refusal to purchase trademark for sale upon the same terms and conditions as offered by prospective trademark purchaser. If after 30days from receipt of notice, Shocker Energy, Inc. does not purchase trademark, Larry Shepard or successor in interest may proceed to sell said trademark.

**Payment Terry Smith.** Terry Smith shall receive 100% of the outstanding ownership interest of the Shocker Companies from the Shepards. The following trademarks shall be retained by Shocker Energy, Inc.:
