## RELEASE OF SECURITY INTEREST IN TRADEMARKS

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is made as of December 21, 2010 ("Effective Date") by Wilmington Trust FSB (as successor agent to Bank of America, N.A.), as Administrative Agent for the Secured Parties referred to in the Guarantee and Security Agreement (as defined below) ("Grantee").

**WHEREAS**, pursuant to the terms and conditions of (i) that certain Trademark Security Agreement, dated as of June 24, 2004, by and between CDOC, Inc. ("CDOC") and Grantee (the "CDOC Trademark Security Agreement"), CDOC pledged and granted to Grantee a continuing security interest in and lien on all of its right, title and interest in and to its Trademark Collateral (as defined in the Trademark Security Agreement), including without limitation the trademark registrations set forth on Schedule A-1 hereto (collectively, the "CDOC Trademark Collateral") together with the goodwill associated therewith and (ii) that certain Trademark Security Agreement, dated as of June 24, 2004, by and between CNO Services, LLC (f/k/a Conesco Services, LLC) ("CNO Services") and Grantee (the "CNO Services Trademark Security Agreement" and, together with the CDOC Trademark Security Agreement, the "Trademark Security Agreements"), CNO Services pledged and granted to Grantee a continuing security interest in and lien on all of its right, title and interest in and to its Trademark Collateral (as defined in the Trademark Security Agreement), including without limitation the trademark registrations set forth on Schedule A-2 hereto (collectively, the "CNO Services Trademark Collateral" and, together with the CNO Services Trademark Collateral, the "Trademark Collateral") together with the goodwill associated therewith;

**WHEREAS**, CDOC, CNO Services and Grantee entered into the Trademark Security Agreements pursuant to the terms and conditions of that certain Guarantee and Security Agreement, dated as of June 24, 2004 (the "Guarantee and Security Agreement");

**WHEREAS**, CNO Services subsequently assigned to CDOC the entire interest of CNO Services in the trademark registrations set forth on Schedule A-2 hereto;

**WHEREAS**, the CDOC Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") at Reel 3011, Frame 0377 on July 23, 2004;

**WHEREAS**, the CNO Services Trademark Security Agreement was recorded with the PTO at Reel 3016, Frame 0315 on July 23, 2004; and

**WHEREAS**, all of the outstanding obligations under the Credit Agreement (as defined in the Trademark Security Agreements) have been paid.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Trademark Security Agreements, and hereby terminates, cancels, re-pledges, reassigns and releases any and all security interests and liens it has against the Trademark Collateral together with the goodwill associated therewith.

If and to the extent Grantee has acquired any right, title or interest to any of the Trademark Collateral or the goodwill associated therewith, it hereby assigns and transfers such rights, title or interest to CDOC or CNO Services, as applicable.


Grantee shall take all further actions, reasonably acceptable to Grantee, and provide to each of CDOC and CNO Services and each of their respective successors, assigns or other legal representatives,

all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by CDOC or CNO Services, each at the sole cost and expense of CDOC or CNO Services, as applicable, to more fully and effectively effectuate the purposes of this Release.
