TRADEMARK COLLATERAL AGREEMENT

This 22nd day of December, 2010, **SMITH MOUNTAIN INDUSTRIES, INC.**, a Delaware corporation (hereinafter, together with its successors in title and assigns, called the "**Debtor**"), with its principal place of business and mailing address at 1000 Dillard Drive, Forest, Virginia 24551, in consideration of ten dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, grants **NEWSTAR FINANCIAL, INC.** ("**NewStar Financial**"), with its mailing address at 500 Boylston Street, Suite 1600, Boston, MA 02116, not in its individual capacity, but in its capacity as the administrative agent and collateral agent hereunder for the Secured Creditors under and as defined in that certain Security Agreement hereinafter defined (NewStar Financial, acting in its capacity as such administrative agent and collateral agent for the benefit of Secured Creditors, and any successor or successors to NewStar Financial acting in such capacity, being hereinafter called the "**Agent**"), liens on, and a continuing security interests in, the following property:

(a) each trademark, trademark registration and trademark application listed on Schedule A-1 hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration and trademark application;

(b) each trademark license listed on Schedule A-2 hereto, and all royalties and other sums due or to become due under or in respect of each such trademark license, together with the right to sue for and collect all such royalties and other sums; and

(c) all proceeds of the foregoing, including, without limitation, all claims by the Debtor against third parties for damages by reason of past, present or future infringements of any trademark or trademark registration listed on Schedule A-1 hereto or of any trademark licensed under a trademark license listed on Schedule A-2 or by reason of injury to the goodwill associated with any such trademark, trademark registration or trademark license, in each case, together with all rights to sue for and collect such damages;

to secure performance of all Secured Obligations as set out in that certain Amended and Restated Security Agreement, dated as of even date hereof, by and among the Debtor, the other debtors party thereto, and the Agent, as the same has been or may be amended, supplemented, modified or restated from time to time (the "**Security Agreement**").

Notwithstanding the foregoing, this Trademark Collateral Agreement shall not operate as a sale, transfer, conveyance or other assignment to the Agent of any applications by the Debtor for any Trademark based on an intent to use the same if and so long as such application is pending without a Statement of Use having been filed and accepted (such pending applications which are based on intent to use being hereinafter referred to collectively as "**Intent-To-Use Applications**").

The Debtor does hereby further acknowledge and affirm that the rights and remedies of the Agent with respect to the liens on and the security interests in the trademarks, trademark registrations, trademark applications and trademark licenses made and granted hereby are more

fully set forth in the Security Agreement, and, in the event of any conflict or ambiguity between this Trademark Collateral Agreement and the Security Agreement, the Security Agreement shall control.
