TRADEMARK ASSIGNMENT

This Trademark Assignment (hereinafter referred to as "Assignment") is effective as of the 21st day of December 2010, by and between Aztec Manufacturing, Inc., a California corporation having a place of business at 13821 Danielson Street, Poway, California 92064 and its predecessor Aztec Washer Company (hereinafter collectively referred to as "ASSIGNOR") on the one hand and Marli Manufacturing Co., Inc., a New York corporation having a place 21 Emma Street, Binghamton, New York 13905 (hereinafter referred to as "ASSIGNEE") on the other hand.

WHEREAS, ASSIGNOR has adopted, used, is using, and is, to the best of its knowledge and belief, the owner of the trademark listed in Schedule A, attached hereto and incorporated herein by this reference, and all other rights appurtenant thereto, including, but not limited to, all common law rights, trade name rights, causes of action, and the right to recover for past infringement (hereinafter collectively referred to as "Trademark");

WHEREAS, ASSIGNOR has acquired goodwill associated with and symbolized by said Trademark and has not abandoned the same;

WHEREAS, ASSIGNOR is the owner of the federal and foreign trademark registrations relating to the Trademark listed in Schedule B, attached hereto and incorporated herein by reference (hereinafter collectively referred to as "Registrations");

WHEREAS, ASSIGNEE desires to acquire all rights, title, and interest in and to the Trademark and Registrations; and

WHEREAS, ASSIGNOR is willing to assign to ASSIGNEE all rights, title, and interest as ASSIGNOR may possess in and to the Trademark and Registrations.

NOW, THEREFORE, for good and adequate consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby irrevocably assigns and sells to ASSIGNEE all rights, title, and interest as ASSIGNOR may possess in and to the following:

- (1) the Trademark set forth in Schedule A; and
- (2) the Registrations set forth in Schedule B;

together with the goodwill symbolized by said Trademark and Registrations concurrent with the transfer of certain tangible assets as indicia of said goodwill.

ASSIGNOR shall forthwith, upon the ASSIGNEE's written request, execute any documents prepared by ASSIGNEE necessary to effectuate the transfer of the aforesaid Trademark and Registrations to the ASSIGNEE. ASSIGNEE will bear the cost of preparing and recording with any Trademark Office any such further documents necessary to effectuate the transfer of the Trademark and Registrations to ASSIGNEE.
