**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interests and liens contemplated hereby.
