**RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL, dated as of December 20, 2010 (the "Release"), is made by Ableco Finance LLC, a Delaware limited liability company located at 450 Park Avenue, New York, New York 10022, as the Collateral Agent for itself and certain lenders (in such capacity, together with its successors and assigns, if any, "Ableco"), in favor of American Color Graphics, Inc., a New York corporation located at 250 West Pratt Blvd., 18th Floor, Baltimore, Maryland 21201 ("American Color Graphics").

W I T N E S S E T H

WHEREAS, American Color Graphics adopted, is using, and holds all right, title and interest in and to, the trademarks and service marks listed on the attached Schedule A, which trademarks and service marks were registered or applied for in the United States Patent and Trademark Office (the "Trademarks");

WHEREAS, American Color Graphics entered into a Pledge and Security Agreement, dated October 17, 2008 (as amended, restated, supplemented, modified or otherwise changed from time to time, the "Security Agreement"), in favor of Ableco, as the Collateral Agent for itself and the other Secured Parties (as defined in the Security Agreement);

WHEREAS, pursuant to the Security Agreement, American Color Graphics granted to Ableco, and granted to Ableco for the benefit of the Secured Parties (as defined in the Security Agreement), a continuing security interest in all right, title and interest of American Color Graphics in, to and under the Trademarks, together with, among other things, the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including without limitation, any and all causes of action which may have existed by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the "Collateral"), to secure the payment, performance and observance of the Secured Obligations (as defined in the Security Agreement);

WHEREAS, Ableco and American Color Graphics entered into that certain Grant of a Security Interest -- Trademarks, dated October 17, 2008 (the "Short-Form Trademark Security Agreement");

WHEREAS, the Short-Form Trademark Security Agreement was recorded with the United States Patent and Trademark Office (the "USPTO") on October 22, 2008 at Reel/Frame No. 3874/0658;

WHEREAS, pursuant to the Short-Form Trademark Security Agreement, American Color Graphics granted to Ableco and granted to Ableco for the benefit of the Secured Parties, a continuing security interest in the Collateral to secure the prompt payment, performance and observance of the Secured Obligations; and

WHEREAS, Ableco wishes to provide a document suitable for recording in the USPTO for purposes of recording the termination, release and discharge of its security interest in the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

Ableco hereby, at the sole cost and expense of American Color Graphics and without any recourse to Ableco or any representation or warranty of any kind (express or implied), terminates, releases and discharges fully its security interest in the Collateral.

Ableco hereby authorizes American Color Graphics or American Color Graphics' authorized representative to record or file this Release in the applicable governmental office or agency in order to memorialize the release of any security interest of Ableco in the Collateral, in each case at the sole cost and expense of American Color Graphics and without any recourse to Ableco or any representation or warranty of any kind (express or implied).

Ableco further agrees to execute and deliver to American Color Graphics any and all further documents and instruments, and do any and all further acts which American Color Graphics (or its agents or designees) reasonably request in order to confirm this Release, in each case at the sole cost and expense of American Color Graphics and without any recourse to Ableco or any representation or warranty of any kind (express or implied).
