RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST (this "Release"), dated as of December 23, 2010, is made by Madison Capital Funding LLC, a Delaware limited liability company, as administrative agent for the Secured Parties (as defined in the Trademark Security Agreement defined below) (the "Agent") in favor of the Grantor (as defined below).

WHEREAS, ProTradeNet, LLC, a Delaware limited liability company (the "Grantor") and the Agent entered into a certain Trademark Security Agreement, dated as of November 29, 2006, made by the Grantor in favor of the Agent (as may be amended, modified, restated or supplemented from time to time, the "Trademark Security Agreement");

WHEREAS, pursuant to the Trademark Security Agreement, the Grantor granted a security interest in the Trademark Collateral (as defined in the Trademark Security Agreement) including the trademarks, trademark registrations, trademark licenses and trademark applications identified on Schedule I attached hereto (the "Trademark Collateral"); and

WHEREAS, the Trademark Security Agreement was recorded in the U.S. Patent and Trademark Office;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby releases and terminates all of its security interest in the Trademark Collateral, whether granted pursuant to the Trademark Security Agreement or any other agreement or document delivered in connection with the Trademark Security Agreement, and the Agent, on behalf of the Secured Parties, hereby reassigns any and all right, title and interest (if any) that the Agent or the Secured Parties may have in the Trademark Collateral to the Grantor.


The Agent agrees, at the Grantor's expense, to cooperate with the Grantor and to provide the Grantor with the information and additional authorization reasonably required or desirable to effect the release of the Agent's security interest in the released Trademark Collateral described herein.
