**TERMINATION AND RELEASE
OF SECURITY INTEREST IN TRADEMARKS**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Termination and Release"), dated as of December 23, 2010, from UBS AG, Stamford Branch, in its capacity as Collateral Agent (in such capacity, together with its successors and permitted assigns, "Assignor") in favor of Data Device Corporation, a Delaware corporation located at 105 Wilbur Place, Bohemia, New York, 11716 ("DDC"), Beta Transformer Technology Corporation, a New York corporation located at 40 Orville Drive, Bohemia, New York 11716 ("Beta"), ILC Dover IP, Inc., a Delaware corporation located at One Moonwalker Road, Frederica, Delaware 19946 ("Dover IP"), and ILC Dover LP, a Delaware limited partnership located at One Moonwalker Road, Frederica, Delaware 19946 (collectively with DDC, Beta and Dover IP, "Assignees").

WITNESSETH:

WHEREAS, pursuant to the First Lien Security Agreement, dated as of August 24, 2005 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), and the First Lien Trademark Security Agreement dated as of June 28, 2006, in favor of Assignor (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "2006 First Lien Trademark Security Agreement"), a first priority security interest (the "2006 First Priority Security Interest") was pledged and granted by Assignees to Assignor and its successors and assigns for the ratable benefit of the Secured Parties in and to all of each Assignee's right, title and interest in, to and under the Pledged Collateral, including with respect thereto, the registered and pending United States federal Trademarks identified on Schedule A to the 2006 First Lien Trademark Security Agreement and the goodwill appurtenant thereto and all other rights appurtenant thereto, including but not limited to all products and proceeds thereof (collectively with any and all other registered or pending Trademarks and the goodwill appurtenant thereto and all other rights appurtenant thereto, including but not limited to all products and proceeds thereof, in which any Assignee pledged and/or granted a security interest to Assignor pursuant to an agreement between such Assignee and Assignor, regardless of whether such agreement is specifically identified herein to the extent securing the Obligations, the "Trademark Collateral");

WHEREAS, the 2006 First Lien Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 11, 2006 at Reel 3345/Frame 0277;

WHEREAS, pursuant to (i) the First Lien Trademark Security Agreement, dated as of August 24, 2005 (the "2005 First Lien Trademark Security Agreement"), a first priority security interest (the "2005 First Priority Security Interest") was pledged and granted by Assignees to Assignor in all of each Assignee's right, title and interest in, to and under certain trademarks including the trademark identified on Exhibit II hereto (the "2005 Trademark Collateral") and (ii) the Second Lien Trademark Security Agreement, dated as of August 24, 2005 (the "2005 Second Lien Trademark Security Agreement"), a second priority interest (together with the 2005 First Priority Security Interest, the "2005 Security Interests") was pledged and granted by Assignees to Assignor in all of each Assignee's right, title and interest in, to and under certain trademarks including the 2005 Trademark Collateral;

WHEREAS, (i) the 2005 First Lien Trademark Security Agreement was recorded with the United States Patent and Trademark Office on September 7, 2005 at Reel 3154/Frame 0465 and (ii) the 2005 Second Lien Trademark Security Agreement was recorded with the United States Patent and Trademark Office on September 8, 2005 at Reel 3155/Frame 0559; and

WHEREAS, Assignor now desires to terminate, release and discharge fully the entirety of its First Priority Security Interest and 2005 Security Interests and any and all other security interests pledged and/or granted by Assignees to Assignor in any and all of Assignee's right, title or interest in, to or under the Trademark Collateral and the 2005 Trademark Collateral, as applicable.

NOW, THEREFORE, for good and valuable consideration, including without limitation the payment or performance in full of the Obligations secured by the Trademark Collateral pursuant to the 2006 First Lien Trademark Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, Assignor hereby states as follows:

1. Definitions. All capitalized terms used but not otherwise defined herein have the meanings assigned to such terms in the Security Agreement.

2. Release of Security Interest. Assignor hereby terminates, releases, and discharges fully its 2006 First Priority Security Interest, its 2005 Security Interests, and any and all other security interests pledged and/or granted by Assignees to Assignor in any and all of Assignor's right, title and interest in, to and under the Trademark Collateral and the 2005 Trademark Collateral, as applicable, including, without limitation, the registered and pending Trademarks identified in Exhibit I and Exhibit II attached hereto, as applicable, together with the goodwill appurtenant thereto and reassigns and transfers to Assignees any and all right, title and interest that Assignor may have in the Trademark Collateral and the 2005 Trademark Collateral, as applicable. For clarity, any and all right, title, and interest of Assignor in, to and under such Trademark Collateral and 2005 Trademark Collateral, including without limitation, the goodwill of the business connected with the use of, and symbolized by, the Trademark Collateral and the 2005 Trademark Collateral and any and all causes of action which Assignor may have by reason of infringement of the Trademark Collateral and 2005 Trademark Collateral, shall hereby be reassigned and transferred to Assignees.

3. Authorization. Assignor hereby authorizes Assignees or Assignees' authorized representatives to (a) record this Termination and Release with the United States Patent and Trademark Office, (b) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of any security interest of Assignor in the Trademark Collateral and the 2005 Trademark Collateral and/or (c) otherwise record or file this Termination and Release with the applicable governmental office or agency.

4. Further Assurances. Assignor hereby agrees to duly execute, acknowledge, procure, and deliver any further documents and to do such other acts as may be reasonably requested by Assignees to effect the termination, release and discharge of the First Priority Security Interest, the 2005 Security Interests and any and all other security interests pledged and/or granted by Assignees to Assignor in any and all of Assignor's right, title and interest in, to and under the Trademark Collateral and the 2005 Trademark Collateral contemplated hereby.
