RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE, dated as of December 23, 2010 (this "Release"), is made by FRESH FOODS FINANCE, LTD. (the "Holder"). All capitalized terms used herein that are defined in the Note, the Security Agreement or the Trademark Agreement (as each such term is defined below) and that are not otherwise defined herein shall have the respective meanings ascribed thereto in the Note, the Security Agreement or the Trademark Agreement.

Reference is made to (a) the Secured Promissory Note dated as of November 12, 2010 (as amended, supplemented or otherwise modified from time to time, the "Note"), issued by Harry's Finance, Inc. ("Finance"), The Harris Soup Company ("Harris Soup") and Harry's Real Estate Partners, L.L.C. ("HREP" and together with Finance and Harris Soup, each, a "Borrower" and collectively, the "Borrowers") to the Holder, (b) the Security Agreement dated as of November 12, 2010 (as amended, supplemented or otherwise modified from time to time, the "Security Agreement"), by and among the Borrowers and the Holder, and (c) the Trademark Collateral Security and Pledge Agreement dated as of November 12, 2010 (as amended, supplemented or otherwise modified from time to time, the "Trademark Agreement"), by and among the Borrowers and the Holder.

Pursuant to the Security Agreement and the Trademark Agreement, among other things, each Borrower pledged and granted to the Holder, a security interest in, among other things, all of each Borrower's respective right, title and interest in and to the trademarks and trademark applications of such Borrower set forth on Annex I hereto (the "Trademarks"), which security interest was recorded with the United States Patent and Trademark Office.

In connection with the termination of the Note pursuant to Section 3(b) of the Note, the Borrowers have informed the Holder of their desire to obtain the release of all rights, title and interest (including, without limitation, all security interests) of the Holder in and to the Trademarks granted under the Security Agreement and the Trademark Agreement.

Accordingly, for good and valuable consideration, receipt of which is acknowledged, the Holder hereby releases and terminates the Lien created by each Borrower under the Security Agreement and the Trademark Agreement, and all other rights, title and interest (including, without limitation, security interests) of the Holder in and to the Trademarks and all other Collateral derived therefrom. The Holder agrees to make Uniform Commercial Code termination statements filings, filings with the United States Patent and Trademark Office, and other filings to evidence the release and termination of such Liens and security interests covering the Trademarks, in each case at the Borrowers' expense.


