GRANT OF SECURITY INTEREST IN TRADEMARKS

FOR VALUABLE CONSIDERATION, the receipt and adequacy of which is acknowledged, MEDRECON, LTD., a Texas limited partnership ("Medrecon") and D. WISE MANAGEMENT CORPORATION, a Texas corporation ("Management" and collectively with Medrecon, the "Grantors" and individually each a "Grantor"), grants to COMERICA BANK, a Texas banking association (in such capacity, "Bank"), a security interest and all of each Grantor's right, title and interest in and to the following whether existing now or later or on which such Grantor now has or later acquires an interest, and wherever the same may be located ("Trademark Collateral");

1. All rights, title and interest (including rights acquired pursuant to a license or otherwise, but only to the extent permitted by the agreements governing such license or other use and without resulting in the abandonment, invalidation or unenforceability of any right, title or interest of either Grantor therein) in and to the following trademarks (collectively, the "Trademarks") described on Exhibit "A".
2. All Proceeds, products, rents and profits of or from any and all the foregoing Trademark Collateral and, to the extent not otherwise included, all payments under insurance (whether or not Bank is the loss payee), or any indemnity, warranty or guaranty, payable by reason of loss or damage to or otherwise in respect of any of the foregoing Trademark Collateral. For these purposes, the term "Proceeds" includes whatever is received or receivable when any Trademark Collateral or other proceeds are sold, exchanged, collected or otherwise disposed of, whether such disposition is voluntary or involuntary.

Each Grantor has granted the security interest under this instrument pursuant to the terms of a Security Agreement dated December 23, 2010 ("Security Agreement") made by Grantors, DWMRC Holdings, Inc., a Nevada corporation, and DWMRC Ventures, Inc., a Nevada corporation, to Bank for the purposes of security as provided in the Security Agreement. Grantors acknowledge and affirm that the rights, privileges and remedies of Bank with respect to the security interest in the Trademark Collateral granted in this instrument are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated in this instrument by this reference.
