

DOES HEREBY CERTIFY:

FIRST: That the Board of Directors of said corporation, by the unanimous written consent of its members, filed with the minutes of the Board of Directors, adopted a resolution proposing and declaring advisable the following amendment to the Certificate of Incorporation of said corporation:

“RESOLVED, that the Certificate of Incorporation of GoAmerica Communications Corp. be amended by amending the Article numbered “First” in it’s entirety, relating to the name of the corporation, said Article shall be and read as follows:

First: The name of corporation is Purple Relay Services Co.”
